

Description

The MAFR-000644-000001 is a single-junction circulator designed for wireless infrastructure applications. It operates over the frequency range of 1805 MHz to 1880 MHz. Insertion loss is less than 0.30 dB over an operating temperature range of –40 °C to +100 °C.

The MAFR-000644-000001 comes in an industry-standard surface mount package and is designed for automated SMT placement.




Figure 1. MAFR-000644-000001 Block Diagram

A block diagram of the MAFR-000644-000001 is shown in Figure 1. The absolute maximum ratings of the MAFR-000644-000001 are provided in Table 1.

Electrical specifications are provided in Table 2. Plating information is shown in Table 3.




Figure 3. MAFR-000644-000001 Tape and Reel Dimensions

Figure 2 shows the package dimensions and recommended PCB footprint. Tape and reel dimensions are provided in Figure 3.



Figure 2. MAFR-000644-000001 Package Dimensions and PCB Footprint
